Berth booking for bands or musicians

Dear Ladies and Gentlemen!

Thank you for your interest in the private project for musicians and bands "Bands & Breakfast"!

For reasons of limited space, Bands & Breakfast is currently geared solely to musicians and bands from abroad for appearances in Switzerland or domestic bands that have appearances in Zurich, but no own vehicles, as the name implies.

We only want bookings from musicians or bands! Discussions with managers or locations do not lead us further, even if we are open to constructive criticism and suggestions for improvement. We would like to emphasize once again that our guests are above all bands and musicians, to whom we would like to dedicate ourselves personally to their well-being and their needs.

Since we currently offer our private 3.5 room apartment for musicians and bands, we must make it clear that the sleeping places are limited to max. 6 people. In individual cases, we can also accommodate other guests, but this must be clearly clarified in a personal dialogue. The sleeping spaces are divided as follows: 2 places in the guest room and 4 places in the living room.

As we are both working full-time as shifts the bookings can only be considered in person no later than 7 weeks before the respective gig, at the least 6 weeks before the gig, after the contract has been submitted. (E-Mail / Facebook scans are very long and will be printed by us!)

Of course, we would be glad to receive invitations to the respective gigs, or signed merchandise, but it is not a must and is solely responsible for the decision of the respective band or musician.

We would like to further state that we keep pets (guinea pig, scorpion in a closed terrarium and budgerigars).

Besides the free food and sleeping, we also offer a special for our guests furnished guests WIFI: Name: Bands & Breakfast, Password: 12345678. Also over our own parking space for vans, the first day for free, from the 2nd day CHF 15.- will be charged.

For organizational reasons, the contracts must not only contain the arrival or departure day, also estimated arrival time to be completed. We would like to further inform you that our current apartment is a smoking apartment. We are happy to take on our non-smoking guest's consideration!

Amendments and / or adjustments of certain components of the contract may only be made by Bands & Breakfast. Adjustments or changes that were NOT made by Bands & Breakfast lead to automatic cancellation of the contract, as well as rejection of the desired bookings.
